Purpose

This supplemental advice letter reflects changes made to the List of Contracts and Deviations as ordered in Resolution W-5006 and Resolution W-4989. Advice Letter 433 was submitted in accordance with General Rule 8.5.6 of General Order No. 96-B for the purpose of modifying San Gabriel's List of Contracts and Deviations to add a recycled water agreement with City of Montebello ("City"). Pursuant to this agreement, San Gabriel will provide recycled water to irrigate City's Grant Rea Park, located partially within San Gabriel's Los Angeles County Division service area. In accordance with Water Industry Rule 7.3.1(3) (compliance with resolution), this advice letter is recommended as Tier 1.

Background

San Gabriel currently provides recycled water service in its Los Angeles County division both under a recycled water tariff (Schedule No. LA-6) and under several contracts previously approved by the Commission.

On March 13, 2014, San Gabriel and the City of Montebello ("City") entered into the Agreement For Recycled Water Service to Grant Rea Park (the "Agreement", appended hereto as ATTACHMENT A) for the purpose of providing City with recycled water service to irrigate landscaping at Grant Rea Park, which the City is currently irrigating with drinking water

(approximately 60 AF/year or 2,178 Ccf/month). Thus, this Agreement conserves a significant quantity of potable drinking water, reduces reliance on imported water, and advances Governor Brown's goal of a 20% reduction in potable water use in response to the recently declared Statewide drought

The Agreement provides that San Gabriel will deliver, through a single metered connection, recycled water at a quantity rate equal to seventy percent (70%) of the general metered rate applicable in its Los Angeles County division (attached hereto as ATTACHMENT B) plus the monthly service charges set forth therein. In consideration of the City's long-term commitment to use recycled water and the significant quantity of local drinking water supplies thereby conserved, the contract rate for recycled water delivered is less than San Gabriel's recycled water tariff Schedule LA-6 which is 85% of the Quantity Rate charged by San Gabriel for general metered service (i.e., potable water), attached hereto as ATTACHMENT C. The Agreement has an initial term of 10 years.

Before recycled water can be delivered to Grant Rea Park, the City requested and San Gabriel agreed to install one metered recycled water connection, for which the City will fully reimburse San Gabriel for this work not to exceed \$30,000 unless written authorization is provided by the City. The contract rate also provides City with an economic incentive to incur the cost of this recycled water connection, construction of which is anticipated to be completed by June 2014.

In addition to conserving a supply of potable water resulting from San Gabriel's service of recycled water to City, existing San Gabriel customers will benefit from the revenues generated under the Agreement. With a 2-inch metered connection, City will pay a service charge of \$168.10 each month under current rates. City also will receive water service from San Gabriel for potable water needs at the park pursuant to San Gabriel's general metered water service tariff schedule.

The matters addressed in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.

Notice and Service

Distribution of this advice letter is being made to the attached service list in accordance with Water Industry Rule 4.1 of General Order No. 96-B. No other parties have requested notification of tariff filings related to the Los Angeles County Division. Since this advice letter does not increase rates or withdraw service, no other notice is required. In accordance with Water Industry Rule 4.3 of General Order 96-B, San Gabriel will also post this advice letter to its website.

AGREEMENT 2937

AGREEMENT FOR RECYCLED WATER SERVICE TO GRANT REA PARK

This Agreement for recycled water service to Grant Rea Park ("Agreement") is entered into as of the 13 day of March, 2014, between San Gabriel Valley Water Company, a California public utility water corporation subject to the jurisdiction of the California Public Utilities Commission ("Commission"), and the City of Montebello, a municipal corporation and public agency of the State of California ("City"). (San Gabriel Valley Water Company and City are at times referred to herein as "Party" or collectively as "Parties.")

RECITALS

- A. San Gabriel Valley Water Company and the City recognize the environmental benefits of using recycled water when it is available in sufficient quality and quantity. The Parties acknowledge that the California Legislature has declared that the use of potable domestic water for non-potable uses such as irrigating parks and landscaped areas is a waste or an unreasonable use of water within the meaning of Section 2 of Article X of the California Constitution if recycled water is available which meets all of the conditions as determined by the State for use of recycled water.
- B. Grant Rea Park is located in San Gabriel Valley Water Company's service area. Recycled water is now available for non-potable use and San Gabriel Valley Water Company is prepared to provide all water service, including, recycled water service, to Grant Rea Park once work to separate the on-site irrigation system from the potable water system is completed in accordance with regulatory requirements.
- C. San Gabriel Valley Water Company actively promotes the use of recycled water by customers in its service area who are able to put it to beneficial use. San Gabriel Valley Water Company is the largest retail service supplier of recycled water in the San Gabriel Valley. In May 2010, Central Basin Municipal Water District ("Central Basin"), a wholesale water supplier, completed construction of an additional segment of its regional recycled water system that extends a new 30-inch pipeline within the City from which San Gabriel Valley Water Company can deliver recycled water to Grant Rea Park.
- D. Through its Parks and Recreation Division, the City strives to provide rewarding recreational programs and services for the community. Delivery of recycled water to Grant Rea Park directly supports the City's efforts to identify and implement environmentally friendly programs for the benefit of its residents and the greater community at a cost which is lower than the cost of potable water.
- E. San Gabriel Valley Water Company and the City recognize that conserving drinking water supplies is urgently needed to assure the present and future sustainability and

reliability of local water resources in the San Gabriel Valley, and further reduce reliance on imported water. The use of recycled water is a cost effective, reliable method of helping to meet the long term water supply needs of the community.

NOW, THEREFORE, the Parties agree as follows:

Section 1: Quantity of Recycled Water Available to City

Subject to the provisions set forth in this Agreement, San Gabriel Valley Water Company agrees to deliver and sell to the City, and City agrees to purchase from San Gabriel Valley Water Company, recycled water to Grant Rea Park through one metered connection referred to in Section 2 of this Agreement. The maximum daily rate of delivery shall not exceed the rate of delivery of recycled water available from Central Basin.

Section 2: Facilities for Delivery of Recycled Water

San Gabriel Valley Water Company will install one metered connection required to deliver recycled water to Grant Rea Park. City agrees to reimburse San Gabriel Valley Water Company for this work at a cost not to exceed \$30,000 unless written authorization is provided by City.

Section 3: Rates for Service

San Gabriel Valley Water Company will provide recycled water service to City subject to and in accordance with the company's applicable tariff rules and schedules including Tariff Schedule No. LA-6 except that in consideration of the City's long-term commitment to use recycled water and the significant quantity of local drinking water supplies thereby conserved, the applicable quantity rate will be equal to seventy percent of the company's General Metered Rate that would otherwise apply to the potable water service.

Section 4: Billing and Payment

San Gabriel Valley Water Company will bill the City monthly for recycled water service which City will pay in accordance with the company's Commission approved billing and payment procedures.

Section 5: Special Conditions

a. City understands and agrees that the recycled water delivered to City is not safe for human or animal consumption and has limited uses. City agrees to use the recycled water only for those uses or purposes that are legally permissible under the laws of the state and the directives of the California Department of Public Health, Los Angeles County Department of Public Health, the Los Angeles Regional Water Quality Control Board, and all other appropriate regulatory agencies.

b. San Gabriel Valley Water Company will supply only such recycled water at such pressure as may be available from time to time from Central Basin. City shall indemnify San Gabriel Valley Water Company and save it harmless against any and all claims arising out of service under this Agreement and shall further agree to make no claims against San Gabriel Valley Water Company for any loss or damage resulting from service under this Agreement.

Section 6: Effective Date and Termination

This Agreement will become effective in accordance with applicable law and requirements from the Commission. This Agreement shall have an initial term of ten years from the effective date of this Agreement and may be renewed by either Party for an additional ten year term by giving written notice to the other Party at least sixty (60) days in advance of the termination date. Thereafter, either party shall have the right to terminate this Agreement at any time by giving sixth (60) days' written notice to the other party.

Section 7: Public Utilities Commission Jurisdiction

This Agreement shall at all times be subject to such changes or modifications by the California Public Utilities Commission as the Commission may, from time to time, direct in the exercise of its jurisdiction.

Section 8: Non-Assignability

This Agreement and any right arising under or by virtue of this Agreement shall not be assigned or transferred by City without the prior written consent of San Gabriel Valley Water Company.

Section 9: Notices

All notices given pursuant to this Agreement shall be in writing and given by personal delivery or by registered or certified mail, delivered as follows or as San Gabriel Valley Water Company and City may hereafter designate in writing:

Section 10: Litigation

Should litigation be necessary to enforce or interpret any term or provision of this Agreement or to collect any portion of any amount payable under this Agreement, the

prevailing party shall be entitled to recover its litigation expenses, including, without limitation, its reasonable attorney fees and expenses and expert witness fees in addition to any other relief to which the prevailing party should otherwise be entitled.
